



VISIT TO MARIKANA AT THE INVITATION OF H.M. KING ELIAS SETUKE 27th APRIL 2022

General Sankara Shezi and I were invited by His Majesty King Elias Setuke to visit His Majesty and the Rustenburg Marikana Community and death site (where 34 miners were murdered with impunity by the SA Police) and the Royal Bafokeng community who have all suffered the injustices of this Government, judiciary and law enforcement.

Emotions overflow when one witnesses the deliberate destruction and abject poverty of a slow genocide forced upon the Marikana community. The unimaginable despotic psychopathy employed against the Marikana community by men who earn \$Billions per annum from a platinum mine hijacked from the Kingdom of Bashiga-ba-Raphana is impossible for ordinary folk to comprehend.

The evidence is in, this is a multi-pronged co-ordinated attack against His Majesty, the Kingdom and the community evidenced by the following;

Legal Recourse; His Majesty has fought for over 27 years in court appearances represented by eminent QCs and Advocates who've been 'unable' to provide any justice through the captured judiciary and legal system. We've evidence of High Court judges issuing fraudulent Court Orders with impunity.

Employment; The community, reduced to trading chicken feet and mealies in muddy roadside conditions not 200 metres from the Bafokeng Royal Platinum Mine (with income in excess of \$17billion p.a.) is a vision that is indelibly ingrained in the memories of witnesses.

Housing; Rows of the most basic tin shacks with no running water, ablutions, toilets or electricity, again 200 metres from the Royal Bafokeng Mine's power station which appears large enough to power a small city.

Blasting; To remove the community, the Mine hands out notices demanding the community vacate their shacks from 4pm until 6pm and proceed to dynamite the ground not 30 metres from rows of shacks forcing them into the bush for hours on end.

Mine security; When the community complain and attempt to demonstrate the Royal Bafokeng Mine Security physically assault them like animals and chase them further into the barren land for hours on end.

Marikana Policing; The police have chased community members away refusing to open any cases of assault against the Royal Bafokeng Mine and or owners.

The Marikina Killing Field; The kopje where 34 miners were slaughtered by police with automatic weapons whilst on a wage strike in 2012 hits home hard and its impossible to stand on the ground unemotionally, unarmed fathers were murdered by the police on orders of the mine owners.

Marikana Investigative Commission; The 'commission' accepted that police acted in 'self-defence' and no-one was found guilty of the murder of 34 Miners. View YouTube videos of the Marikana massacre evidencing a military style massacre.

President Ramaphosa fled for his life on the 1st of May 2022 as workers stormed the stage whilst he insultingly offered them a R1000 per month and among many mistakes he spoke down to the community as if they're fools. My view, they're awake to the shenanigans of the mine and owners.

Where do we go from here ? Silently witness the continuing slow genocide of the Marikana community?
